Corona questionnaire for infection protection - declaration by a legal guardian

For the access of **adults** to Hurricane Factory Berlin GmbH the following terms do apply: Visitors have to be either fully vaccinated (14 days after the final vaccination) or recovered from (28 days to 6 months after a positive PCR test) and need an additional official test result. For **minors** the following regulations do apply:

- a) **minors younger than 6 years:** exemption of the test obligation
- b) **minors 6 years and older:**
 - b.1 vaccinated or recovered**
the according certificates are sufficient, an additional test is not necessary
 - b.2 school children**
school children, who are tested regularly due to the effective state ordinance in connection with their school attendance, do not need an additional test to visit Hurricane Factory Berlin, the legal guardian confirms the regular testing and negative test result by signature
 - b.3 other minors**
for minors, which do not attend school, a negative test result is required - rapid test not older than 24 h or a negative PCR test result not older than 48 h

In addition, you acknowledge the hygiene concept of Hurricane Factory Berlin as binding and confirm herewith, that you have read it personally, that you have understood the hygiene concept und that the minor will abide by the hygiene rules. Furthermore, you have been informed that administrative fines which are eventually imposed by the authorities due to your personal wrongdoing, have to be paid by yourself.
