Minors need the signature of a legal guardian to fly at Hurricane Factory Berlin. For all children and adolescents, which are not accompanied by a legal guardian on the spot, the **prior declaration of consent by a legal guardian** is required. A copy or photo of the identity card of the legal guardian has to be attached to this declaration of consent.

The signatory declares that he/she is the legal guardian of the minor and gives his/her approval of the participation of the minor at the wind tunnel flight at Hurricane Factory Berlin GmbH. Furthermore, the signatory confirms by his/her signature, that the minor has been informed about the following terms and conditions and will comply with them.

Declaration of participation for minors

Herewith it is acknowledged that the participant:

- feels healthy and has no acute injuries of the bone structure, particularly no shoulder injuries. Furthermore, there are no existent cardiovascular diseases, nerve diseases or any other diseases which could be a potential restriction for the flight participation. There is no pregnancy existent.
- is not under the influence of alcohol or any other narcotics or drugs at the moment of the flight
- will successfully complete the necessary flight briefing about the topic "behavior in the wind tunnel and safety regulations" observantly and conscientiously
- will follow the instructions of the staff

The participant and the legal guardian are aware that the offered flight experience by Hurricane Factory Berlin GmbH might hold an injury risk; the participant takes part in the booked flight at his/her own risk.



Use of collected data

Personal data will only be collected at the necessary extent, the Hurricane Factory protection of data privacy practice is according to data protection regulations as the Datenschutz-Grundverordnung (DSGVO) / General data protection regulation (GDPR).

The herewith collected data will be stored by Hurricane Factory Berlin GmbH, Waßmannsdorfer Allee 3, 12529 Schönefeld – hereinafter abbreviated "HF" – for the purpose of internal statistics and as documentary evidence in case of eventual litigation or claim issues. The data will be processed and will be stored in hardcopy and digital form on internal data carriers of the operating company. The HF provides information corresponding to Art. 15 / DSGVO, which of your data has been stored.
