I hereby acknowledge and declare:

- that I will obey the instructions of the staff.

I am aware that the offered flight activities of the Hurricane Factory Berlin GmbH might comprise a risk of injury; I participate in the tunnel flight at my own risk.

Use of personal data

Personal data will only be collected at the necessary extent, the Hurricane Factory data protection policy is consistent with the data protection regulations as defined in the General Data Protection Regulation (GDPR).

The collected data will be stored by Hurricane Factory Berlin GmbH, Waßmannsdorfer Allee 3, 12529 Schönefeld - hereinafter abbreviated as "HF" – for the purpose of internal statistics and as evidence in case of dispute or claim. The data will be processed and stored in hardcopy form and digitally on internal data carriers of HF. According to paragraph 15 of GDPR the HF provides information at any time about which of your data has been stored.

With the signature given below the HF gets the approval for the collection and storage of the herewith compiled personal data. The personal data will not be passed to third parties or published except within the above stated process.

The signee agrees with the receipt of commercial and marketing related information to the above denoted e-mail address. This approval can be retracted (also partially) at any time by a plain written declaration to HF.

Declaration of agreement to the use of photos and videos
