**For 8-Way Indoor FS:** In order to be able to score the competition entries, a minimum number of four (4) teams or competitors (for solo competitions) is required. If the minimum number of teams or competitors in a given discipline is not reached, no German Champion will be determined.

However, at the request of the field of participants, the possibility can be set up to still hold the discipline in question in order to use the results as a qualification for international competitions.

### Goals

- Determine the German Champion and standings of the competitors in each of the mentioned disciplines



- Gaining knowledge about the qualification level and performance level in Germany
- Support competitive sports and juniors
- Bringing indoor skydiving and skydiving closer to the general public by promoting the German Nationals via press, radio and TV.
- Strengthening the indoor and outdoor skydiving community
- Achieving new records
- Training and continuing education of Judges

### **Preliminary remark**

The main purpose of the event is to find the German Champion in 8-Way Formation Skydiving considering the rules of the FAI and the federal commission Skydiving (BKF). The event also intends to make indoor skydiving and outdoor skydiving known to the general public and to make it accessible for everyone.

Another purpose of the event is to highlight the inclusive character of our sport by including disciplines for juniors starting with the age of 7.

### **Judging**

In accordance with the BKF (Federal Commission Skydiving) competition regulations for German Skydiving Championships 2023 version 10.

### **Protest procedures**

Protest procedures in accordance with the FAI/ISC Sporting Code, Section 5 regulations.

### **Rules and number of competition rounds**

The official rules for all disciplines can be found here <https://www.dfv.aero/Sport/Wettbewerbe/Wettbewerbsregeln>. Rules are based on the current FAI/ISC Sporting Code, General Section, Section 5 – Skydiving, the *Wettbewerbsordnung Deutsche Meisterschaften (WDM) 2023 Version 10* (if applicable for Indoor Skydiving) and the current regulations and dive pools for each disciplines.

- **4er IFS** 10 rounds with 35 seconds working time each round
- **8er IFS** 10 rounds with 50 seconds working time each round
- **Kids-Challenge** 2 compulsory rounds, 3 free routine rounds

### **Different rules to the existing FAI rules for HF Cup 2025**

#### **Schedule**

Competition entries will be grouped into blocks. Each team will fly two entries in every block with a break of at least 3 minutes between each entry. The break between every block will be at least 45 minutes.

This schedule does not apply to the KIDs Challenge. The speed settings and the individual rounds of the KIDs challenge take place on Saturday.



## Judging

### Entries

Competition flights are judged live by observing the team in the airstream or on a video screen. Judging can also be done after viewing the recorded video material.

### Number of judges

At least three experienced video analysts or judges (including the video software technician) must evaluate the performance of each team. They are supervised by a chief judge who validates the performances.

### Scoring protocol

The video analysts or referees count the number of formations and the number of penalties live.

Once the team's performance is complete, the video analysts and judges confer. They may review specific parts of the flight at any speed using the video recording. If they agree, they announce the score and validate it under the supervision of the chief judge. If they disagree, the score will be shown as "not validated". In this case, a video analyst or judge will immediately evaluate the performance using the video recording, or the flight will be reviewed immediately after the end of the round.

### Protests

Written protests against the outcome of a judgment must be no later than 15 minutes after its publication. After this period, the judgment becomes final.

A protest can be lodged against a performance evaluation. The protest must be in writing and as precise as possible. It may not refer to a team other than that of the protester.

A protest against a performance evaluation is a joker that can be used once per team during the entire competition. This joker will be returned if the request is justified.

The chief judge will assess the admissibility of the protest. If it is accepted, the protested points will be reviewed. The flight can be re-evaluated in its entirety. In the case of a valid protest (with the exception of the performance evaluation), the jury will decide. To ensure compliance with the decision taken, the jury can contact a member of the "Regulations" working group before each publication. Decisions made by the jury are final.

## **Participation requirements**

**For 8way FS:** Every competitor must be a member of the DFV (Deutscher Fallschirmsportverband *German Skydiving Association*) or of the DAeC (Deutscher Aero-Club *German Aero-Club*). Please prove your membership via submitting your membership ID upon sign up for the competition.

This participation requirement does **not** apply to non-German competitors or teams and does also not apply to attendees for the FS4 competition as well as the KIDs-Challenge.

It is each competitor's responsibility to use equipment which is appropriate for the according discipline he/she intends to compete in. Equipment will be checked by the event organizers. The minimum equipment required is a suitable flying suit, shoes, helmet (without any camera mounts), hearing protection (provided by the wind tunnel) and goggles (if applicable). An appropriate protection is welcome.

With the sign up for the competition every competitor accepts the terms and conditions for the event. Not following the rules can lead to a disqualification of a competitor or a whole team. Each participant individually agrees to follow the organizer's instructions in connection with the competition.

The participation for each competitor is limited to maximum two (2) disciplines and two (2) sub-disciplines with the limitation to only one (1) class. VFS is counted to artistic disciplines. A participation in three (3) or more sub-disciplines is not permitted.

Example: Discipline: **FS** / Sub-Disciplines: **FS4 / FS8** – Classes: **Open, Female, Intermediate** etc.

This means for example: A competitor can compete in the discipline FS in two teams as long as those teams are **not** competing in the same class within the same sub-discipline. Therefore, a competitor in FS can attend in a FS4 team and in a FS8 team, but not in two FS4 or two FS8 teams at the same time.

The event organizer will not accept sign ups of competitors if the above restriction is exceeded.

## **Anti-Doping**

According to the requirements of the national anti-doping agency (NADA) and the Deutscher Olympischer Sportbund (DOSB), doping tests will be carried out at our German Nationals in Indoor Skydiving. **All competitors** are subject to the possibility of being called in for such a doping control.

It is expected that up to 5 (five) competitors will be selected for doping tests. The current Anti-Doping regulations and measures can be found on the homepage of the DFV (<https://www.dfv.aero/Sicher/Medizin+Gesundheit/Doping>) or can be requested via the DFV office.



If you are taking a medication indicated by NADA/WADA for medical reasons, your intake must be reported using the TUE (therapeutic use exemption) form before the start of the competition. The relevant forms can be requested from the DFV office or directly from NADA.

### **Video and photo rights**

When registering for the competition, all participants agree to transfer their rights to their own image, especially with regard to footage taken during the event, for the duration of the competition and beyond with the organizer to use and share, including for use in the context of public and press work.

Late registrations after the deadline are only possible with the approval and confirmation of the organizer. Late registration fee is 15 € per person on top of the normal registration fee stated above.

## **Cancellation**

If a competitor or team does not compete after a successful registration for the competition the organizer refunds the costs for the flying time (competition entries and speed setting rounds, price depends on the discipline) but not the costs for the organization fee, the goodie bags and the dinner buffet /after party.

**A cancellation before 7<sup>th</sup> of January 2025 will be 100% refunded.**

**Due to the still unstable situation at the energy market the organizer reserves the right to cancel the event in whole or in part if a sudden increase in energy costs is putting the economic viability of Hurricane Factory Berlin GmbH at risk. In the case the event is being cancelled by the**



**organizer the registration fee will be refunded. 50,00 € of the registration fee will be withheld to cover costs for the organization of the event.**
