With an approval of Aeroklub ČR sport skydiving committee Hurricane Factory Prague is holding the 12th Czech Open 2026 – indoor skydiving nationals. At the occasion of the event, flyers with disabilities will be able to compete in Indoor Para Skydiving Race.

Date and place of the event

The competition will be held on **Friday and Saturday 16.01. – 17.01.2026** at Hurricane Factory Prague, Tupolevova 736, Praha 9.

Goal of the competition

- Raise and compare the level of sport performance in indoor skydiving.
- Consolidate friendly relationships among athletes.
- Popularize indoor skydiving to the public.
- Promote social inclusion through indoor skydiving as a sport.

Organizational instructions

Registration of the competitors will take place **until 31.12.2025** when the registration will be closed.

Registration fee

Handifly Race – 2 200 CZK

Registration fee is to be returned only in case the organizer cancels the event.

Registration fee includes raffle tickets (1 ticket/competitor). It is possible to buy more raffle tickets for 150 CZK per ticket.

Registration fee can be paid cash at the reception desk of Hurricane Factory or by a bank money transfer to bank account.

The local restaurant will offer refreshments during the event.

Parking is possible to a limited extent on the street Tupolevova or at the OC Letňany parking lot.

Announcement ceremony

The winner will be announced up until the 3rd position.

The minimum number of competitors for the competition to take place is three.

General establishments

Competitors who are not citizens of the Czech Republic can also attend the competition.

Condition for attendance is to have at least a basic experience with indoor skydiving and their disabilities need to be eligible regarding the Annex 1 – Eligible Impairments.

The competition is organised by **Hurricane Flyers Club z.s.**

Protests can be filed only until the end of the competition and with a deposit of 1 000 CZK. The protest will be decided on by a person chosen and authorised by the organiser. Unless the protest is upheld the deposit is forfeited in favour of the competition organiser.

Registration and classification of the competitor

The competition is open to all competitors who meet the conditions for participation, up to date with their registration and that have validated their classification.

Registration is to be done online at: <https://hurricanefactory.com/prague/en/mcr-2026/> Competitor will fill out the first and last name and other necessary information.

Validation of classification

For competing, Flyers need to be allocated a Compensation Coefficient based on their individual disability situation. Your classification's process need to be made as soon as possible before January 5th, 2026. This operation must be carried out at the same time as registration, but it is an independent process that must be completed in addition and at least 2 weeks before the competition.

- If you have previously already submitted Evaluation Items and been evaluated by a Classification Board and if your physical condition or use of eventual Specific Equipment has not changed since: You are not requested to mandatory submit new Evaluation Items. If you do not send new Evaluation Items, your coefficient will be assessed using your previous Items.
- If you have never participated to any Indoor Para Skydiving Race, or if you have an old expired Evaluation (before 2024), or if you want to be re-Evaluated using new Items: You need to send your Evaluation Items to Jérôme David's: Email: vr4france@hotmail.com or WhatsApp: +33.6.35.29.95.42

The Evaluation Items to be submitted are the following:

- The official Declaration and consent form completed and signed [Declaration and consent form for Athlete Evaluation](#)
- (Eventually) One or more photo/or video images showing your deficiencies outside from the flight chamber.
- One or more video images showing you in Flight in a wind tunnel and using your eventual Specific Equipment. These video images must show either Flights on the Handifly Race or at least demonstrations of ability to fly up, down and front and to contact the inner wall of the flight chamber.
